It is a privilege to serve the people of the Seventh Council District. As I reflect on the last four years and the challenges that we've faced, I am most proud of the resilience and collaboration of community members equally committed to partnering to create a lasting change and hold each other up during these most uncertain times.

From wildfires to COVID-19, the vulnerabilities associated with food and housing insecurity have been amplified, along with decades old environmental concerns but together we will continue our work to turn that corner. In 2021 I expanded services directly to our community, from testing and vaccines to growing food pantry services made exclusively to our residents. My team and I worked tirelessly to deliver a greater share of resources to meet the need.

When city services were cut as a cost savings due to pandemic spending, I created the MRod Volunteer Corps and expanded Operation Bright S.P.O.T. to keep our neighborhoods clean. I led the fight to protect \$60 million in local public transportation dollars and launched our new DASH system to provide more reliable transit options for our community. I created our city's first Youth Development Department, because I know our young people require greater resources and support post pandemic.

I invite you to learn more about what's been accomplished in this annual report and see it as the foundation for the additional work and services I will continue to fight for in the months ahead.

# COVID-19 Mobile Vaccine and Testing Sites

Secured free COVID-19 testing sites in the Seventh Council District. Once vaccines were available, mobile vaccine sites were launched in Pacoima, Sylmar, and Sunland-Tujunga. The first mobile vaccine site was located in Pacoima, the community that was heavily impacted by COVID-19. Vaccines are provided at different locations throughout the district to ensure that individuals who walk or rely on public transportation have access to the vaccine.

# COVID Care Kits

Since the beginning of the pandemic more than 2,500 COVID Care Kits have been provided to community members and local health care providers. The kits contain Personal Protective Equipment (PPE), hand sanitizer, cleaning solutions and directions on how to properly disinfect against the virus. The Care Kits were given to LAFD to place on rescue ambulances in the Seventh Council District to be left at homes where they were called for a COVID-19 positive patient. In January 2021, the LAFD program was implemented citywide to help combat the rising cases of COVID-19.

### Vaccine Outreach at Hansen Dam

Partnered with Visión y Compromiso to conduct outreach at Hansen Dam every Sunday during March where they distributed PPE and delivered vaccine education to all park attendants.

### Business Outreach for Vaccines

Canvassed local businesses on Cesar Chavez Day of Service to inform business owners and staff that they were eligible for the COVID-19 vaccine. Staff at local businesses were registered for the vaccine and flyers were left at businesses to encourage additional staff members to get vaccinated.

# COVID-19 Vaccines for Homeless

Partnered with the Mayor's Office of City Homeless Initiatives, the Los Angeles Fire Department, and the Community Organized Relief Effort Team to provide COVID-19 vaccines to individuals experiencing homelessness near Hansen Dam. This collaborative partnership allowed us to visit over 65 locations in our district, and a total of 94 individuals were vaccinated.

### COVID-19 Vaccines at Local Businesses

Secured a mobile vaccination unit at Vallarta Market in North Hills. This mobile vaccination unit increased the vaccination rate in the district by making it convenient for those shopping at local businesses to receive their vaccine.

### PPE Distribution with Khalsa Care

Partnered with City of Los Angeles, Department on Disability and Khalsa Care to provide PPE for disabled families and individuals. Attendees also received boxed groceries and art supplies. With the help of community organizations that serve this population, over 600 families were selected to receive groceries and PPE.

### PPE Distribution at Holy Cross Hospital

Partnered with Shepherd Hills Church to deliver over 200 items of PPE to Providence Holy Cross Hospital in Mission Hills.

### \$25,000 Grant from California Community Foundation

Obtained a California Community Foundation grant of \$25,000 that was used to distribute gift cards to over 300 low income Sylmar families. They were also provided with bags of PPE to protect their family during the pandemic.

### COVID Community Update with Holy Cross Medical Center

Partnered with Holy Cross Medical Center to host a press conference on the severity of the Delta variant and the need to increase vaccinations to stop the spread.

### Food Distribution

Partnered with North Valley Caring Services (NVCS) to secure a grant of up to \$15,000 from SoCalGas to supplement food distribution and programming at NVCS.

### Holiday Food Box Distribution

Hosted a food box distribution to provide 1,000 boxes of food the week between Christmas and New Year, a time food banks typically close leaving many families without food and resources. Boxes included dry foods, vegetables and poultry. The council office worked with local food pantries, churches and community organizations to identify families in need across the district.

### Thanksgiving Turkey Giveaway

Partnered with local nonprofits, churches and schools to host a Thanksgiving Turkey Giveaway for more than 1,000 families in need. Families were provided with a turkey and ingredients for a complete Thanksgiving meal.

Homelessness

### CARE and CARE+ Services Resume

Resumed CARE and CARE+ services in the City of Los Angeles to remove trash and debris from homeless encampments. Since service has resumed, more than 35 locations in the district have been cleaned with 12 locations cleared of all encampments.

# Homeless Resource Fair

Hosted a resource fair for individuals experiencing homelessness where individuals learned about job opportunities and transitional housing programs. Attendees also received PPE, vaccines, clothing and toiletries. Partner organizations for this event included North Valley Caring Services, Community Organized Relief Effort (CORE), the Los Angeles Fire Department (LAFD), Pennylanes, About My Father's Business, Chrysalis, and Teens 4 Teens.

# Metamorphosis on Foothill

Completed construction on this new 48-unit permanent supportive housing development in Sylmar, to provide units for 48 unhoused individuals.

# Silva Crossing

Broke ground on Silva Crossing, a project that will provide another 56 units of supportive housing. This project was made possible in part by \$10.9 million in voter approved HHH bond funding.

### Good Nite Inn

Opened the Good Nite Inn, the district's first Project Homekey site, with funding from a California state grant. The location provides 85 units of permanent housing for seniors and medically vulnerable individuals.

### Encampment to Housing

Housed 35 individuals from the Osborne/210 lot in a multi-jurisdictional effort. The site is on Caltrans, Army Corps of Engineers and SoCal Edison properties that is located in a high fire severity zone that had been the site of past fires. Taking the lead to coordinate with the agencies, individuals on the lot were housed.

### Brand Park Encampment Housing

Collaborated with the Los Angeles Homeless Services Authority (LAHSA) and the Recreation and Parks to house 15 individuals at Brand Park and remove more than 2,600 pounds of waste.

### PPE for Schools to Resume in Class Learning

After more than a year of distance learning, Los Angeles Unified School District students returned to campus this past fall. To ensure their safety, personal protective equipment including masks and hand sanitizer was supplied to local schools.

# School Supplies

Partnered with organizations including LA Family Housing and Khalsa Care Foundation to distribute school supplies to families in need. Over 700 families received the supplies they needed for their students to start the school year. More than 4,000 masks and 300 bottles of hand sanitizer were provided.

# Principal Luncheon

Hosted a Principal's luncheon and round table to express gratitude to the principals and school administrators. Principals from across the Seventh Council District participated and shared the challenges and opportunities faced around their school, especially during the pandemic.

# Speed Awareness in School Zones

Produced and distributed banners for speed awareness near schools in the district to promote safe driving in school zones.

### Youth Development Department

Secured \$1.4 million budget allocation for the City of Los Angeles' first Youth Development Department. The Youth Development Department will be the catalytic change that delivers increased program options for young people, greater accountability of tax payer dollars and will streamline access to ensure equality for all young Angelenos regardless of their zip code.

### Legislation to Close Whiteman Airport

Introduced a motion that was approved by the City Council calling for the closure of Whiteman Airport. The residents of the Northeast San Fernando Valley bear the burden and environmental pollution from this airport while receiving no benefit from airport operations. The motion calls on the County of Los Angeles, who operates the airport, to evaluate alternative uses for the property to provide economic opportunity, housing, and open space for this community.

### Installed No Oversize Vehicle Parking Signs

Introduced a motion that was approved to install "No Oversize Vehicle Parking" restrictions throughout the district to reduce the number of large vehicles parking on streets.

### Safety in Equestrian Communities

Actively worked with multiple city departments to increase safety in equestrian neighborhoods by improving crossings, increasing street lighting, and implementing traffic safety projects on equestrian trail corridors.

### No Dumping Signs in Sylmar

Four "No Dumping" signs were installed in Sylmar on Olden Street from Ralston Avenue to Bradley Avenue to address illegal dumping and blight in the neighborhood.

### Illegal Dumping Measures in Sunland-Tujunga

In collaboration with the Department of General Services, installed a series of 'No Dumping' signs alongside the Big Tujunga Canyon Road and Oro Vista Avenue. Additionally, a gate and barriers were installed across Oro Vista Avenue to help prevent access onto the hillside for illegal dumping and trespassing on a city-owned property.

# MROD Volunteer Corp

MRod Volunteer Corps was created as a community partnership to host cleanup events throughout the district. At the inaugural event in North Hills, more than twenty volunteers joined staff to clear and remove bulky items from Orion Avenue and Langdon Avenue.

### San Fernando Road and Montague Street Cleanup

Coordinated a clean up with the LA Sanitation Department's Environmental Compliance Inspectors at San Fernando Road and Montague Street. The area was overrun with debris and bulky items. Working together, inspectors identified what items were personal property and what items were debris and were able to clear this area.

### Pacoima Earth Day Celebration

Partnered with Pacoima Beautiful in honor of Earth Day to clean the area of Pinney and El Dorado and along Van Nuys Boulevard.

### Burnt RVs Removed

In partnership with LA Sanitation Department, Los Angeles Police Department, and Los Angeles Department of Transportation (LADOT) we removed an inoperable and hazardous recreational vehicles from the streets of our district. This past year, we removed 10 recreational vehicles from the public right of way.

### Tree Maintenance in Sylmar

Worked with the Urban Forestry Department to remove six dead trees, grind down six stumps, and prune 16 trees on the 13000 block at Bradwell Avenue.

### Register Your Horse Event in Sylmar


Hosted the Register Your Horse event which included live entertainment, COVID-19 testing and vaccines, and low cost horse licensing and microchip services at Stetson Ranch in partnership with LA Animal Services. Licensing helps with evacuation planning in the event of an emergency. 87 horses were registered and 29 horses received microchips while 35 COVID vaccines were administered to attendees.

### Wilson Canyon Park Brush Clearance

Directed the Mountain Recreation and Conservation Authority (MRCA), which manages Wilson Canyon Park, to conduct yearly brush clearance at the park. Community members voiced their concerns about the fire danger from the overgrown brush. MCRA cleared cured grass, limbed trees, and dry foliage within 200 feet from structures of defensible spaces. Operation Bright S.P.O.T.

### Operation Bright S.P.O.T.

Operation Bright S.P.O.T. is a targeted neighborhood cleanup program launched in the Seventh Council District. Cleanups focus on major commercial corridors and include street sweeping, power washing sidewalks, litter pickup and weed abatement. The crew also picks up bulky items from residential neighborhoods.



### Completed Renovation of North Valley City Hall

Completed a much-needed renovation of North Valley City Hall in Tujunga, an aging municipal building. Updated this space for constituent services, as well as community meetings and events, with energy-efficient features, modernized security features, and audiovisual/technical upgrades, among many other improvements.

### Pacoima Little League Improvement Project

Secured \$565,000 for improvements to the Hansen Dam Baseball fields including new fencing and backstop, aluminum bleachers, concrete paving and walkways, and irrigation upgrades. The project also included site grading, removal of excess soil and planting of new trees.

### DeGarmo Avenue Lighting Upgrade

Worked with the Los Angeles Department of Water and Power (LADWP) and the Los Angeles Bureau of Street Lighting to install five new utilitarian lights on DeGarmo Avenue from Roxford Street to the dead end-north of DeGarmo Avenue.

# American with Disabilities Act (ADA) Sidewalk Updates

Worked with LADWP to upgrade 630 square feet of sidewalks and two new ramp installations to meet the American with Disabilities Act (ADA) Standards on Eldridge Avenue Between Astoria Street and Dryer Street.

### Completed Lake View Terrace Traffic Safety Improvement Project

Partnered with LADOT to complete Foothill Blvd traffic safety improvement project in Lake View Terrace, between Osborne and Wentworth, to reduce speeds and collisions resulting in fatalities and serious injuries. Project included narrowing lanes, removing parking, restriping, and adding more signage and bollards to maximize shoulder space for vulnerable road users, such as equestrians, pedestrians, and cyclists.



### New Left-Turn Phasing Signals

Partnered with the LADOT, to install a left-turn phasing signal at the intersection of Devonshire St and Sepulveda Blvd in Mission Hills.

### HAWK Beacons Installed at Horse Crossings

Secured \$1.7 million to install HAWK beacon crossings for the equestrian community. Three have been installed, including at Foothill Boulevard/Christy in Lake View Terrace, as well as Wentworth Street/Mary Bell and Wentworth Street/Wheatland in Shadow Hills. An additional HAWK beacon is scheduled to be installed next year at the intersection of Olive View/Bulcher in Sylmar, and funding was secured for a brand-new HAWK beacon crossing at the Johanna/Sunland Boulevard intersection in Shadow Hills.

### Transit Oriented District Specific Plan

Secured staffing necessary to complete a Transit Oriented Community Plan for the communities along the future Metro East San Fernando Valley Transit Corridor line. This forward-thinking plan will identify land use recommendations and strategies for the preservation and expansion of affordable housing opportunities along the corridor.

### Verdugo Hills Pool Bathhouse Renovation

Secured an additional \$700,000 towards completion of the pool and bathhouse renovation.

### Sylmar Senior Center

Secured \$1 million for feasibility and initial design for the establishment of a senior center in Sylmar.

### Hubbard Street/ Dronfield Sidewalk Improvement

Secured \$620,000 for sidewalk and curb ramp improvements along the south side of Hubbard Street from Dronfield to Foothill.

### Maclay Street Reconfiguration

Secured \$1.7 million for a roadway improvement project that includes concrete improvements and signal/signage/striping work on Maclay Street north of the I-210 freeway.

# Sylmar DASH

LD XING

Launched a new DASH Route in Sylmar as a result of a \$200,000 grant secured in 2018. The grant funded a study to evaluate the feasibility of a hyper local approach to connecting students and members of the community with public transportation that takes them where they need to go.

# Bike Lanes Installed

Partnered with LADOT to install bike lanes along Chatsworth Street from Chatsworth Drive to Sepulveda Boulevard.

### Hansen Dam Mile Markers and Trailhead Signs

Installed new trailhead signage and 29 mile markers in the Hansen Dam Recreation Area. This \$75,000 investment funded bilingual signs that include braille and a grid system so those using the trails now have a method to track their route or share their location in an emergency. The way-finding system increases park access for the surrounding community and ensures emergency personnel can easily navigate the basin.

# Caltrans Cleanups

Organized community members to hold Caltrans accountable for freeway cleanups. Freeways, onramps, and offramps are not the jurisdictions of the City, and we must rely exclusively on Caltrans to do their part to clear and maintain these areas. After the office and constituents pushed for cleanups in the district, Caltrans has increased their maintenance. The office is continuing to push for Caltrans to clear and maintain these areas.

### Sylmar Upper East Canyon Channel Improvements

Held a community meeting to solicit input from community members on potential improvements ranging from creating a pedestrian path with an open channel to a closed channel with pedestrian and equestrian uses. Investments in this channel would range from \$4 million to \$12 million.

### Stetson Ranch Park Community Meeting

Organized a community meeting with local equestrians to gather input on the improvements community members would like at Stetson Ranch park. As one of the few city parks with equestrian amenities, this park is a popular location for the Sylmar equestrian community.

# Lighting Improvement Project in Howard Finn Park

Secured \$100,000 in funding to increase lighting in this Tujunga park and completed installation of new fixtures.

### Mission Mile Sepulveda Project

Secured \$39.7 million in funding for the milestone Mission Mile Sepulveda project. The project is just one of four Los Angeles projects that made it to the regional Metropolitan Planning Organization list for Active Transportation Program funding in this cycle. Sepulveda Boulevard was identified as a priority corridor due to the high volume of traffic deaths and severe injuries. This project will increase safety for all who drive, walk, bike, or take public transportation in Mission Hills and North Hills on Sepulveda Boulevard from Rayen to Rinaldi.



### Oro Vista Avenue Urban Flow Management Project Community Meeting

Secured \$10.5 million in Measure W funding for the Oro Vista Urban Flow Management and held the first community meeting on this project. This project will capture, treat and percolate water runoff. A new reinforced concrete storm drain will be constructed with 13 new catch basins to capture water from large rain events and convey it to the channel. The project will include the installation of pervious sidewalks, infiltration planters and new street trees.

### Tujunga Canyon Boulevard Green Street Project

Secured \$3 million to install Permeable concrete sidewalks, Bioswale Islands, Infiltration Planter, Street trees, and double drywells Systems to improve water quality and increase water supply while beautifying the neighborhood.



### Glenoaks Green Street Project

Completed the \$3.24 million Glenoaks-Filmore Stormwater Capture investment. This project captures stormwater and urban runoff from a 115-acre watershed and infiltrates the captured water into the ground. This improves local water quality, limiting the amount of urban runoff with trash, bacteria and other pollutants from being swept into the LA River.

# Cool Streets in Sylmar

Worked with StreetsLA to break ground on the City of Los Angeles "Cool Streets" program and install cooling pavement technology on 35 street segments totalling to approximately 11 lane miles in Sylmar. This cooling pavement technology is designed to bring down the temperature of the street by an average of 10 degrees in the hottest of summer days. Additionally, approximately 185 planting sites were identified to plant new trees along selected streets.

# Climate Resilient Trees Planted in Lake View Terrace

Partnered with the City of Los Angeles Department of Recreation and Parks and Los Angeles Beautification team to secure funding for planting and watering of new trees. In Hansen Dam, 79 new trees were planted and 42 were planted in Orcas Park.

# Pacoima Tree Giveaway

Distributed nearly 200 trees to community members at events held at Ritchie Valens Park. The trees can be planted in residents' yards to improve the tree canopy in the district.

### Community Beautification Grant Proposal

Partnered with North Valley Caring Services for a grant to revitalize the parkways located in North Hills. The plan was selected to move to the second round of the grant proposal.



### Hansen Dam Revitalization

Secured \$1 million for a feasibility analysis, hydrology, and geotechnical studies to be completed to explore the possibility of revitalizing Holiday Lake, a community priority identified in the Upper LA River Tributaries Revitalization plan (ULART).

### Introduced a Motion Calling for Closure of Whiteman Airport

Introduced a motion in response to the November 2020 Whiteman Airport accident in Pacoima. The motion calls for a report back on the steps necessary to close Whiteman Airport with an environmental report establishing the toxic nature of the airport's presence and impact on the surrounding community. In addition, the motion directs a report back on alternative uses for the site.

### Valley Generating Station Methane Gas Leak Legislation

Introduced a motion that instructed LADWP to provide immediate relief to residents after a year-long methane leak was reported. The motion requires LADWP to provide immediate relief and create resources to benefit residents impacted by harmful emissions. In addition, it directs LADWP to develop and fund a plan to install air quality monitors near the site.

# Rain Barrel Giveaway

Provided rain barrels to residents as tools to combat the drought and bring the environmental practice to their homes. Through this effort, more than 4,000 rain barrels have been distributed and millions of gallons of rainwater captured.

### Valentine's Day Senior Gift Bags

Hosted the fourth annual Valentine's Day Senior Ball virtually giving seniors in the community PPE and a gift from the council office.

### Dia de Los Muertos

Brought back the Dia de Los Muertos festival in Pacoima with a pandemic safe celebration. The event featured community altars, food trucks, entertainment and COVID vaccines and testing.

### Movie Nights at Hansen Dam

Hosted two movie nights at Hansen Dam featuring Sponge Bob Square Pants and Grease. The events included food trucks, popcorn, sand castle building, and COVID vaccines and testing. Families enjoyed watching movies from the pool at this end of summer event.







# Utility Boxes

Commissioned local artists to complete 39 utility artbox murals that discourage graffiti while adding public art to the community. The art boxes are located in Sylmar, Pacoima, Mission Hills and North Hills.

### Veterans Day Virtual Parade

Participated in the San Fernando Valley Veterans Virtual Parade and Drive Thru Donation and honored 150 veterans for their service.

### Mothers Day Virtual Celebration

Celebrated mothers, grandmothers, and all the special women in our lives for Mother's Day with a free drive-thru plant giveaway.

# Holiday Tree Lightings

Hosted holiday tree lightings in Pacoima, Sylmar and Sunland-Tujunga. Attendees enjoyed photos in front of the tree, hot cocoa, churros, holiday entertainment and more. Vaccines and COVID testing were also available.

# Community Visioning Virtual Workshop

Held a virtual Community Visioning workshop for residents to share ideas for community improvements and provide input to improve city services. The input provided will be used to prioritize future projects that are important to residents.

# COVID Meeting with Los Angeles County

Convened public safety committee meeting with Los Angeles County Public Health Department officials. Committee members were briefed with an update on the pandemic and the current measures in place to reduce the spread of COVID.



### Held First Community Safety Advisory Council for Community Safety Partnership

Held the first meeting for the advisory council of the Community Safety Partnership (CSP) program for the San Fernando Gardens. The CSP program, implemented at the San Fernando Gardens is a collaboration between the community and LAPD to create safer communities.

# Resumed Neighborhood and Business Watch Programs

Resumed programs for residents and business owners to meet with LAPD for public safety updates. Business Watch groups met virtually with LAPD. Neighborhood Watch meetings resumed with Senior Lead Officers to discuss crime and safety programs in the neighborhood.



### Opportunities for Youth

Dedicated \$3.3 million of reinvestment dollars to youth jobs training programs as an alternative to policing.

### Community Police Advisory Board Public Safety Meeting

At this meeting, residents brought up their concerns about illegal fireworks which led to the creation of the inaugural fireworks buyback program.

### Sylmar Fire Station

Secured \$1.8M for pre-development and design activities associated with the development of a new fire station in Sylmar.

### Introduced Illegal Fireworks Motion

Introduced a motion to curb the use of illegal fireworks in the City of Los Angeles, The motion led to the Los Angeles Police Department (LAPD) fireworks portal opening earlier than in past years as a tool for residents to report illegal fireworks in their area.

### Hosted Pilot Fireworks Buy Back Program

Hosted the inaugural fireworks buy back program in Los Angeles resulting in over a quarter ton of fireworks being voluntarily turned in by residents. In exchange for illegal fireworks, residents received gift cards equal to the value of the fireworks turned in.



### Joint Public Safety Committee and Board of Police Commissioners Meeting

In a historic meeting, the Public Safety Committee and Board of Police Commissioners met to learn more about community based public safety approaches. Speaker Aqeela Sherrills, a nationwide expert in community violence intervention, shared his experience in leading public safety reform through community focused initiatives in cities throughout the nation. Attendees also heard from Joshua Young, Deputy Senior Vice President of Justice Initiatives for the Center of Policing Equity, who spoke about reform initiatives needed to create equitable policing practices.

# Bicycle Safety Event

Joined the Community Safety Partnership (CSP) to promote bike safety at the San Fernando Gardens. Residents of the Gardens learned about bike safety and were able to obtain information about resources in the community.

### Illegal Street Racing Motion

Introduced a motion to address the illegal street racing occurring throughout the City of Los Angeles. The motion directed the Los Angeles Department of Transportation and the Los Angeles Police Department's Street Racing Task Force to provide recommendations for traffic calming measures that can be implemented at locations where illegal street racing occurs. It further recommends quarterly meetings to report street racing data and updates to Council Offices.
