



FOOTHILLS & LAKE VIEW TERRACE **COMMUNITY ACCOMPLISHMENTS**

Increasing Public Safety

- Installed 10 speed feedback signs along Foothill Boulevard in Sunland-Tujunga, a pedestrian hybrid beacon on Wyngate Street and Foothill Boulevard, and a left-turn phasing signal at Mount Gleason Avenue and Foothill Boulevard.
- Secured over \$300K in overtime funding for the repair and fortification of over 480 street lights in the district that had been in the dark for several months due to copper wire theft and vandalism. Repaired lights include multiple light segments surrounding Fenton Avenue Elementary School in-between Eldridge Avenue, Pierce Street, Gladstone Avenue, and Glamis Street.
- Secured \$1.2M in this year's budget for LAFD's Wildland Fuel Management Hand Crew which addresses brush fires during fire season and performs mitigation and maintenance work during fire off-seasons.

Addressing Homelessness

- Successfully housed and provided supportive services for 20 individuals who were previously encamped in Shadow Hills in partnership with LA Family Housing, Healthcare In Action, the Los Angeles Homeless Services Authority (LAHSA), and the County of Los Angeles Department of Mental Health.
- Collaborated with the Los Angeles Police Department, LA Sanitation, the Los Angeles Homeless Services Authority, and property managers to successfully clear La Tuna Canyon Road from RV's on both public and private property.
- Scheduled recurring CARE/ CARE + operations for our most chronic locations, removing health hazards, trash, and debris from the public right of way and offering outreach services with opportunities for housing.

Delivering Resources to the Foothill Communities

- Broke ground on the Verdugo Hills Pool, a \$9.4 million pool and bathhouse renovation project, including new ADA-compliant upgrades, remodeling of the locker rooms, addition of a gender-neutral bathroom, reconstruction of the pool deck to incorporate new plumbing and security lighting, refurbishment of bathhouse electrical power and lighting, and security enhancements.
- Repaired a broken guardrail on Wentworth Avenue between Wheatland Avenue and Shadow Hills Avenue.
- Increased Animal Services extra patrol surrounding Stonehurst Recreation Center.
- Deployed Operation Bright S.P.O.T, an initiative I created, to conduct weed and litter abatement, sidewalk power washing and tree stump removal on our major commercial corridors including Foothill Boulevard in Sunland-Tujunga, and La Tuna Canyon.
- Completed street resurfacing on Foothill Boulevard between Esko Avenue and Christy Avenue, Foothill Boulevard between De Garmo Avenue to Filbert Street, Jouett Street between Cometa Avenue to Dronfield Avenue, Hillhaven Avenue between Apperson Street and Valmont Street, Sunland Park Drive, Wyngate Street between Plainview Avenue to Mt. Gleason Avenue.

Building Community

- Hosted the first of its kind large scale Emergency Preparedness Event and Resource Fair at Hansen Dam in partnership with City Departments to coordinate safety drills and update emergency evacuation plans across our district and the San Fernando Valley.
- Hosted the 2nd Annual Pet Resource Fair and Blessing of the Animals in partnership with El Pueblo Los Angeles at Orcas Park in Lakeview Terrace, with over 400 people in attendance.
- Conducted 4 civic engagement workshops with Foothill Schools between a partnership with the Housing Department, Department of Transportation, and the Los Angeles Police Department.
- Partnered with community members to have 4 community cleanups and tree watering events from Lakeview Terrace to Sunland Tujunga.
